 - a. A Special Board of Trustees Meeting was held at the Barrington Area Library on April 23, 2018 regarding the Lake Zurich Road Realignment Project. The Village's Board of Trustees attended the Library Board meeting. The Library Board decided to cease negotiations with the Village regarding the Intergovernmental Agreement for this key project. Therefore, Lake Zurich Road will not be realigned to Berry Road. The Village is moving forward with the underpass project on Route 14. A less desirable alternative to lower Lake Zurich Road into the underpass will be pursued. The Village's Board of Trustees is disappointed with the decision of the Library Board.
