MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BARRINGTON

Monday, January 26, 2015

CALL TO ORDER

The Regular Meeting of the President and Board of Trustees was called to order by Village President Karen Darch at 8:00 P.M. on Monday, January 26, 2015 in the Village Board Room, 200 South Hough Street, Barrington, Illinois. Pastor Zina Jacque from The Community Church of Barrington led the Pledge of Allegiance and gave the invocation.
