### TERMS AND CONDITIONS

1. PARKING PERMIT FEES FOR THE NORTH COMMUTER PARKING LOT ARE NON-REFUNDABLE.
2. THE \$180 FEE IS FOR A CALENDAR QUARTER OR FOR ANY PART OF A CALENDAR QUARTER. THE FEE WILL NOT BE PRO-RATED.
3. PARKING IS CONTINGENT UPON THE AVAILABILITY OF SPACES. PURCHASE OF A PARKING PERMIT DOES NOT GUARANTEE OR RESERVE SPACE TO THE PERMIT HOLDER. SPACES SHALL BE MADE AVAILABLE AND UTILIZED ON FIRST COME PRIORITY BASIS.
4. THE USE OF MUNICIPAL OFF-STREET PARKING LOTS OPERATED BY THE VILLAGE OF BARRINGTON SHALL BE SUBJECT TO SUCH REGULATIONS ADOPTED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF BARRINGTON AS THEY DEEM NECESSARY AND AS SUCH REGULATIONS MAY BE MODIFIED, AMENDED OR REPEALED FROM TIME TO TIME.
5. USE OF PERMIT LIMITED TO LOT #17. USE RESTRICTED TO HRS. 5PM TO 10AM MON.-FRI. EXCEPT THAT VEHICLES MAY BE LEFT IN LOT #17 OVER THE WEEKEND FROM 5PM FRI. THROUGH 10AM MON., SUBJECT TO ADDITIONAL CONDITIONS OUTLINED HEREIN. WEEKEND PARKING PRIVILEGES (FRI 5PM TO MON 10AM) IS PROHIBITED DURING ANY SNOWFALL OR CLEAN - UP OPERATIONS FOLLOWING A SNOWFALL AND AT ANY OTHER TIME IN WHICH NOTICE IS GIVEN THAT THE LOT WILL NOT BE AVAILABLE DUE TO MAINTENANCE. DURING THE WINTER MONTHS, THE PERMIT HOLDER IS HEREBY ADVISED THAT HE/SHE WILL BE PARKING AT HIS/HER OWN RISK OF BEING TOWED DUE TO SNOW REMOVAL OPERATIONS – **NO FURTHER NOTICE SHALL BE GIVEN.** THE VEHICLE IS ALSO SUBJECT TO BEING TOWED IF NOT REMOVED FOR OTHER MAINTENANCE WORK FOR WHICH NOTICE IS GIVEN.
