MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BARRINGTON

Monday, November 9, 2015

CALL TO ORDER

The Regular Meeting of the President and Board of Trustees was called to order by Village President Karen Darch at 8:00 p.m. on Monday, November 9, 2015 in the Village Board Room, 200 South Hough Street, Barrington, Illinois. Trustee Todd Sholeen led the Pledge of Allegiance and a moment of silence was held in honor of all of our veterans as we celebrate Veteran's Day this week and in special memory of George VanHagen who recently passed away.

Upon roll being called the following answered present: Trustees Sue Padula, Pete Douglas, Jason Lohmeyer, Todd Sholeen, and President Karen Darch. Trustee Jim Daluga & Tim Roberts were absent. Also present were: Jeff Lawler, Village Manager; Jason Hayden, Director of Community & Financial Services; Peg Blanchard, Director of Economic & Community Development; Mark Werksman, Director of Public Works; Dave Dorn, Police Chief; and Jim Arie, Fire Chief.

1. VILLAGE PRESIDENT'S REPORT:

President Darch wished to send her condolences to the family and friends of George VanHagen who passed away last week. He was a veteran and longtime resident of the Village of Barrington. She also noted that this Wednesday the community will have a chance to honor our veterans with a special ceremony that will take place at Village Hall at 11:00 A.M. In addition, she wished Trustee Jim Daluga good health who will be undergoing surgery. Lastly, President Darch also wished to congratulate Barrington's High School

football team on behalf of the Board for the outstanding season that they had this year.

2. VILLAGE STAFF REPORTS

Mark Werksman, Director of Public Works, provided a report regarding winter weather preparedness.

Jim Arie, Fire Chief, provided an update and explanation regarding an item (*4e) on tonight's consent agenda.

She noted that 2015 is coming to a close and that the Village has had a great year with the addition of 35 new businesses for a net gain of 29. In addition, Peg noted that she was excited to announce that the former Egg Harbor space will have a new tenant in Southern Belles Pancake House and they should open sometime after the 1st of the year. She also provided an update regarding the businesses at the Barrington Village Center and the addition of Spring Donut. Peg also noted that Heads Up Boutique continues to grow and that the added "Heads Up Shirt Shop" to the business. She also provided an update regarding two businesses that have relocated. They included: The Grooming Lodge (now at 415 N. Hough St.) and Starbucks (now at the Barrington Village Center). Lastly, she encouraged everyone to shop local and asked people to save the date for two upcoming events. They included: the "Holiday Wine Walk" (November 21st) and the "Annual Tree Lighting" (December 5th).
