## MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BARRINGTON

## **CALL TO ORDER**

The Regular Meeting of the President and Board of Trustees was called to order by Village President Karen Darch at 8:05 p.m. on Monday, June 12, 2017 in the Village Board Room, 200 South Hough Street, Barrington, Illinois. Mark Werksman, Director of Public Works led the Pledge of Allegiance.

## 1. VILLAGE PRESIDENT REPORT

President Darch commended the Barrington Park District and the Junior Women's Club on a successful dedication and opening of the new Splash Pad at the Park District pool. President Darch also thanked those that had worked on and supported the 20<sup>th</sup> Anniversary of Relay for Life, where a total of \$5MM has been raised for the American Cancer Society. She also noted that June 14 is Flag Day and reminded everyone to commemorate this day and fly the U.S. flag.

### 2. VILLAGE STAFF REPORTS

Mark Werksman, Director of Public Works reviewed the Village's water conservation program. The matrix of the Village Watering Ordinance was presented and discussed. The Village is in the "Yellow" phase right now. Each village resident needs to pitch in to conserve water.

Peg Blanchard, Director of Economic Development provided an updated on some new businesses in Barrington. She noted that the Barrington Village Center is now 100% leased. She also noted that Gnarly Knots Pretzel Company will open on Hough St. during the week of June 19<sup>th</sup>. In addition, Shirley's at 105 N. Cook Street features music and entertainment. Flesk Brewing will open its craft brewery in the Ice House Mall on June 17<sup>th</sup>. Peg Blanchard asked to please remember and support those businesses affected by the Village's sanitary sewer replacement project. She also noted that parade applications for the 4<sup>th</sup> of July Parade are due by June 15<sup>th</sup>. The dates for Sidewalk Days have been moved to July 6, 7, and 8 to better coincide with other Village activities – on that Sunday downtown business hours will be from 11am to 3pm.
