MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BARRINGTON

Monday, April 26, 2010

CALL TO ORDER

The Regular Meeting of the President and Board of Trustees was called to order by Village President Karen Darch at 8:11 P.M., in the Village Board Room, 200 South Hough Street, Barrington, Illinois. Nancy Bachmann, First Church of Christ Scientist, gave the invocation and led the Pledge of Allegiance.

ROLL CALL

Upon roll being called the following answered present: Trustees Beth Raseman, Trustee Hunt, Jim Daluga, Steve Miller, Jeff Anderson and President Karen Darch. Trustee Roberts was absent. Also present were: Jeff Lawler, Village Manager; Peg Blanchard, Director of Economic and Community Development; Greg Summers, Director of Engineering and Building; Jerry Libit, Chief of Police; Jim Arie, Fire Chief, and Tony Solano, Barrington Courier.

In compliance with the provisions of Chapter 11, "Rules for Participation in Meetings Via Electronic Means" of Title 1, "Administration", of the Village of Barrington Village Code, no member participated in said meeting via electronic means.

President Darch asked the Board if there were any additions, corrections or deletions to the Revised Agenda that was placed on the dais. None were noted.

MOTION: A motion was duly made by Trustee Daluga and seconded by Trustee Miller to approve the minutes of the April 12, 2010 Regular Meeting of the Corporate Authorities, as presented.

ROLL CALL: Trustee Raseman, aye; Trustee Hunt, aye; Trustee Daluga, aye; Trustee Miller, aye; Trustee Roberts, absent; and Trustee Anderson, aye. President Darch declared the motion passed.

REPORTS OF VILLAGE OFFICIALS

1. VILLAGE PRESIDENT'S REPORT

President Darch congratulated BACOA on celebrating their 25 year anniversary. She provided an in depth CN update and noted that they will be holding a hearing in Washington on Wednesday, April 28th. She also noted that the Village did receive updated information regarding the median barrier that CN will need to install on Route 59. This is a requirement in order to have the quiet zone extended. Additionally, President Darch noted that there were several municipal organizations (BACOG, NWMC) down in Springfield last week for the Illinois Municipal League's Lobby Days speaking to legislators regarding various bills that are in front of the House and Senate. Lastly, she wished to congratulate the Firefighter/ Paramedics that were sworn in as well as Assistant Fire Chief Wenschhof on his promotion.

2. VILLAGE STAFF REPORTS

Jeff Lawler, Village Manager noted that there would be two staff reports given tonight.

Jim Arie, Fire Chief gave a presentation regarding "Severe Weather Outdoor Warning Alert Systems" in an effort to educate the public on what actions should be taken in the event of severe weather. He also encouraged the public to attend a fundraiser that will be taking place on Wednesday, April 28th from 5:00-10:00 P.M. at the local Baskin Robbins. This fundraiser is in support of the "National Fallen Firefighters Foundation" and will feature 31 cent scoops of ice cream. Chief Arie noted that on a national level, Baskin Robbins donates \$100,000 towards the cause.

Peg Blanchard, Director of Community and Economic Development wished to inform the local residents that the Village will be bringing back the Barrington Art Festival and that it will be taking place on May 29th and 30th from 10 A.M.-5 P.M. This event will feature 140 juried artists from all over the country, two stages of entertainment, and food from local vendors. Lastly, Peg noted that Cruise Nights would be returning on June 3rd and she encouraged residents to attend both of these events.
