# MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BARRINGTON

Monday, August 20, 2012

#### **CALL TO ORDER**

The Regular Meeting of the President and Board of Trustees was called to order by Village President Karen Darch at 8:07 P.M. on Monday, August 20, 2012 in the Village Board Room, 200 South Hough Street, Barrington, Illinois.

President Darch appointed Melanie Marcordes, Deputy Village Clerk, as recording secretary.

#### ROLL CALL

Upon roll being called the following answered present: Trustees Beth Raseman, Jim Daluga, Steve Miller, Robert Windon, and President Karen Darch. Trustees Paul Hunt and Tim Roberts were absent. Also present were: Jeff Lawler, Village Manager; Peg Blanchard, Director of Economic & Community Development; Greg Summers, Director of Engineering & Building; Mark Werksman, Acting Director of Public Works; Jerry Libit, Police Chief; and Morgan Delack, Barrington Patch.

In compliance with the provisions of Chapter 11, "Rules for Participation in Meetings Via Electronic Means" of Title 1, "Administration", of the Village of Barrington Village Code, no member participated in said meeting via electronic means.

Tim Bergen, 937 Lakewood Drive, Barrington spoke regarding the proposed Ace Hardware store and voiced his concerns with the variations being asked for. He suggested that a traffic study be reviewed once the store has opened to verify there aren't further traffic implications.

Greg Dallstream, Barrington Honor Ride & Run, gave a presentation regarding the Barrington Honor Ride & Run event, which benefits Ride 2 Recovery.

Nancy Davis, 630 Fairfield Drive, Barrington spoke regarding the proposed Ace Hardware store and voiced her concerns with the variations being asked for.

#### REPORTS OF VILLAGE OFFICIALS

#### 1. VILLAGE PRESIDENT'S REPORT

President Darch noted that summer is winding down and she hopes that people will come out to the end of summer events (Cruise Nights). She noted that school is starting tomorrow, and asked the people be especially aware of rules set up by the schools and to be aware of an increased number of children walking to schools. President Darch gave a special thanks to John Brown and his family for bringing forward this Ace Hardware. Heinen's Fine Foods will be opening on Wednesday and we welcome them to Barrington. She also congratulated Wickstrom on their new open house and thanked them for all they do in Barrington. The Village Board will be directing the Plan Commission to review a bike plan that has been put together by our staff and an entire committee of volunteers. She noted that there has been some good information in the Daily Herald regarding the Emerald Ash Borer. The Village Board is working on a public information meeting for September so that people have an opportunity to be completely informed of the steps that Barrington has taken regarding EAB. Finally, President Darch congratulated Matt Blanchard, Peg Blanchard's son, on being the #4 quarterback for the Bears. We congratulate him and wish him luck!

#### 2. VILLAGE STAFF REPORTS

Jeff Lawler, Village Manager, congratulated Shauna Recupito, Police Department, on her 5 year anniversary; Alison Chmelik, Community & Financial Services, on her 10 year anniversary; and Amy Palmeri, Police Department on her 20 year anniversary.

Kevin Kramer, Planner, gave a presentation regarding the process that the Ace Hardware went through and addressed some of the residents concerns. The Board asked several questions and discussed this proposal. The Board asked that our police chief pay extra attention to traffic issues through May 2013 (6 months after the opening of Ace Hardware) and report back to the Village Board to re-look at any traffic issues that might arise.

Peg Blanchard reminded residents that there are 2 more weeks of Cruise Night and that the Farmer's market continues until October 18<sup>th</sup>. She also reported on a new event – Fashion Night Out, September 6<sup>th</sup> beginning at 5:00 p.m. She also welcomed Heinen's Fine Foods, which will open on Wednesday, August 2<sup>nd</sup>. She thanked them for employing a number of local students and residents within our community. She also welcomed Barrington Running company, located at 135 Park Avenue. Peg Blanchard also congratulated Ciao! Baby on their one-year anniversary, Acacia Organics on their 3<sup>rd</sup> anniversary, and Subway's 2<sup>nd</sup> anniversary with their new owners. She thanked Mr. Brown for bringing an Ace Hardware back to Barrington. Finally, she noted that the developer is pre-leasing the Hough-Main project, so if you are looking for office space within the community, they have some availability. They will be at Cruise Night this week with details of the project.

Trustee Raseman thanked the Brown family and staff for their perseverance in getting the Ace Hardware done and for listening to and addressing concerns. She also noted that the Village will be working with an architect for the White House building to assess options for the site.

Trustee Daluga thanked Bob Lee and Greg Dallstream for their presentations. He also thanked Tim Bergen and Nancy Davis for speaking tonight, as it demonstrates their love and concern for the community. He thanked John Brown for his work on the Ace Hardware.

Trustee Miller shared that we are excited for Ace Hardware and hopes that people support it when it opens. On behalf of Trustee Hunt, he asked that people be aware that children are back to school and to drive safely.
