# MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BARRINGTON

Monday, September 28, 2015

#### **CALL TO ORDER**

The Regular Meeting of the President and Board of Trustees was called to order by Village President Karen Darch at 8:11 p.m. on Monday, September 28, 2015 in the Village Board Room, 200 South Hough Street, Barrington, Illinois. Reverend Zina Jacque from the Community Church of Barrington led the Pledge of Allegiance and gave the invocation.

**MOTION:** A motion was duly made by Trustee Sholeen and seconded by Trustee Padula to approve the minutes of the September 14, 2015 Regular Meeting of the Corporate Authorities, as presented.

# 1. VILLAGE PRESIDENT'S REPORT:

President Darch provided an update regarding the Civil War reenactment that took place last weekend (September 19<sup>th</sup> & 20<sup>th</sup>) at Citizens Park as part of the Sesquicentennial activities and she thanked all of those that made the event a success. She also provided an update regarding the annual Illinois Municipal League meeting that she attended in Chicago. In addition, she provided an update regarding the open house

that recently occurred at Barrington's White House and thanked the volunteers that hosted the event. President Darch also informed Village residents regarding some of the items on tonight's consent agenda as they pertain to the forthcoming winter. She reminded members of the community that Homecoming would be taking place this weekend and provided an update regarding the festivities that will be taking place. Lastly, President Darch provided an update regarding BACOG and the work that they have been doing looking to coal tar sealants.
