1. Purchase Two (2) Police Vehicles: According to the equipment replacement and depreciation cycle and included in the 2021 budget, there are several police vehicles due to be replaced in 2021. The vehicles being replaced, at this time, include a 2017 Ford Police Interceptor and a 2015 Dodge Charger. The 2017 Interceptor will be replaced with a 2021 Dodge Durango and the 2015 Charger will be replaced with a 2021 Charger. Both vehicles replace current patrol vehicles, and the Durango will provide extra room for police gear and offers all-wheel drive for added traction in poor weather conditions. Roesch Truck Center in Elmhurst holds the contracts awarded by the Suburban Purchasing Cooperative, to which the NWMC belongs. As members of that Conference, Barrington is entitled to the fleet pricing associated with Roesch. Staff is seeking approval at the March 15th Board meeting to replace both patrol vehicles.

- 1) President Darch discussed a recent article which appeared in the Chicago Tribune regarding groundwater in the Chicagoland area. The article reviewed Joliet's recent initiative to tap into Lake Michigan water vs. continuing to get its water supply from its deep underground aquifer, whose levels have dropped significantly. She explained that Barrington gets its water supply from a shallow aquifer, vs. the deep aquifer that Joliet and some other Chicagoland municipalities must use. A series of updates will be provided via the Village of Barrington E-Newsletter regarding water in the Barrington area and BACOG groundwater survey information.
- 2) Patty Dowd Schmitz provided an update on the following upcoming events: The Memorial Day weekend Art Festival; and the Mother's Day Run. A detailed update of the proposed Spring and Summer Events will be presented on 3/15/2021.
