PURPOSE(S), USE(S), AND INTENT OF PROPOSED FACILITY:

The following must be attached to and accompany the Application:

- A. An accurate location map and site plan. The site plan shall depict the location of all facilities proposed and all existing utilities above and below ground based upon J.U.L.I.E. locates, all of which shall also be field staked for inspection by the Village.
- B. A written traffic control plan as required by Chapter 3 of Title 8 of the Village Code.
- C. An emergency contingency plan as required by Chapter 3 of Title 8 of the Village Code.
- D. A landscaping plan as required by the Village Code.
- E. A Certificate of Insurance naming the Village, its Trustees, officers, employees, and agents as additional insured with coverages as required by the Village Code.
- F. Proof of posting with the Village of security funds, if required.
- G. A written request for any variances from the Village Code which may be applicable.
- H. Additional information as requested by the Village as required by Chapter 3 of Title 8 of the Village Code.
- I. Copy of Certificate of Public Convenience and Necessity or other regulatory authorization obtained by the Applicant related to the facility or Applicant's system which includes the facility.
- J. For Natural Gas and Petroleum Product Pipeline systems, written specifications for the proposed pipe size, design, design standards, construction class, and operating pressures and maximum working pressure.
- K. For water and sewer lines, evidence that all applicable requirements of the Illinois Environmental Protection Agency have been or will be satisfied.
- L. A written agreement or other form of written permission granted to the Applicant authorizing the use of any existing private facilities and/or private property proposed to be utilized for any part of the utility facilities or construction project.

The Applicant agrees to and is responsible to ensure that all work is performed in compliance with all Village Ordinances, as well as all conditions applicable to permit approval, if granted, notwithstanding any errors or omissions in plans or in inspection(s) by Village officials. The Applicant understands and agrees that the issuance of any permit by the Village pursuant to this Application does not authorize the Applicant to utilize the private facilities and/or private property of others.

Under penalties as provided by law and pursuant to Section 1-109 of the Illinois Code of Civil Procedure, the undersigned certifies that the statements set forth in this Application are true and correct, that the undersigned is the duly authorized agent of the Applicant and the utility for this purpose, and that any changes in or amendments to the information contained in this permit Application shall be submitted by the utility and/or the Applicant in writing to the Village within thirty (10) days after the event or occurrence necessitating such change or amendment.

The attached Permit Application has been approved subject to the Applicant's timely and continued compliance with the following conditions:

- A. Residential Notification: The Village requires that all residents adjacent to the area of construction be notified in writing by the Applicant of the proposed work one (1) week prior to commencement of any proposed work. Such notice shall include, among other things: (1) the name and telephone number of a contact person who can answer residents' questions or concerns relative to the proposed work; (2) date of commencement of the work; and (2) anticipated date of completion of the work, including restoration of the job site. At the same time such notice is provided to the affected residents, the Applicant must also provide a copy of such notice, as well as a list of the addresses to which it was sent, to the Village via fax or e-mail in order to verify to the Village that the affected residents were notified.
- B. Public Safety: Open excavations shall not be left unprotected at any time during the day or night. Reflective barricades, plywood over open holes, and protective tape shall be used at all times. Public safety must be a priority at all times.
- C. Communication: When crews are working, there must be a person(s) on site capable of answering questions regarding the work, should the Village or resident have questions and there shall also be a copy of the approved permit on site.
- D. Littering/Debris Clean-Up and Street Cleaning: The Applicant shall keep the construction site clean and free of litter and/or debris at all times, and the Applicant shall clean all affected streets at the end of each work day during construction. Littering or dumping of debris on public or private property is also prohibited.
- E. Restoration Work: All restoration work related to construction occurring during the months of April through October, inclusive, shall be completed within thirty (30) days of completion of the construction activity related to that permit. All restoration work related to construction occurring during the months of November through March, inclusive, shall be completed by May 15th thereafter. Any and all pavement openings occurring during the months of November through March, inclusive, shall be restored with temporary cold patch, with final pavement restoration completed by May 15th thereafter. The Applicant shall be responsible for maintaining the temporary cold patch until final pavement restoration.
- F. ADA Compliance: The Applicant shall be required to upgrade to the current Village standard any and all ADA accessible routes that are impacted or modified during the proposed construction activities.
