### TERMS AND CONDITIONS

1. Quarterly commuter parking hang tags are issued on a calendar quarter basis. The cost of the hang tag is \$195.00 per quarter. Hang tags may be purchased throughout the quarter when available, and in such event, the fee shall be prorated based on the number of days remaining until the expiration date. Should you need to forgo your hang tag at any point during the quarter, your fee may be prorated based on the number of weeks remaining in the quarter based upon a thirteen week quarter. Hang tag must be returned to the Village Hall prior to a refund being processed.
2. Quarterly Hang Tags are non-transferable and cannot be resold by the permit holder.
3. Parking is available in both the North and South Commuter Parking lots and is contingent upon the availability of spaces. The purchase of a Quarterly Hang Tag does NOT guarantee or reserve a space to the permit holder. Spaces shall be made available and utilized on a first come first served priority basis.
4. The use of Municipal Off-Street Parking Lots operated by the Village of Barrington shall be subject to such regulations adopted by the President and the Board of Trustees of the Village of Barrington as they deem necessary, and as such regulations may be modified, amended or repealed from time to time.
5. No overnight parking is allowed in any Village parking lot with this hang tag.
6. There will be a \$10.00 fee for a replacement hang tag.
