### TERMS AND CONDITIONS

- Reverse commuter parking tags are issued on a calendar quarterly basis. The cost of the hang tag is \$200.00 per quarter. Hang tags may be purchased throughout the quarter when available, and in such event, the fee shall be prorated based on the number of full or partial weeks remaining until the expiration date based upon a thirteen week quarter. Should you need to forgo your hang tag at any point during a quarter, you fee may be refunded on a prorated basis based on the number of weeks remaining in the quarter based upon a thirteen week quarter. Hang tag must be returned to the Village Hall prior to a refund being processed.
- Reverse Commuter Hang Tags are non-transferable and cannot be resold by the permit number.
- Parking is contingent upon the availability of spaces. The purchase of a parking permit does not guarantee or reserve a space for the permit holder. Spaces shall be made available and utilized on a first come first served priority basis.
- The use of Municipal Off-Street Parking Lots operated by the Village of Barrington shall be subject to such regulations adopted by the President and the Board of Trustees of the Village of Barrington as they deem necessary, and as such regulations may be modified, amended or repealed from time to time.
- The use of the hang tag is limited to Lot #17. Use is restricted to the hours from 5:00 p.m. to 10:00 a.m. Monday through Friday, except that vehicles may be left in Lot #17 over the weekend from 5:00 p.m. Friday to 10:00 a.m. Monday., subject to additional conditions outlined herein. Weekend parking privileges are prohibited during any snowfall or clean-up operations following a snowfall and at any other time in which notice is given that the lot will not be available due to maintenance. During the winter months, the permit holder is hereby advised parking is at one’s own risk of being towed due to snow removal operations. **NO FURTHER NOTICE SHALL BE GIVEN.** The vehicle is also subject to being towed if not removed for other maintenance work for which notice is given.
- There will be a \$10.00 fee for a replacement hang tag.
