TERMS AND CONDITIONS

1. Parking Permits for the South Commuter Lot are NON-TRANSFERABLE and cannot be resold by the permit holder. South Lot Permits are not valid in the North Commuter Lots.
2. South Lot Permits, while limited in number, are carefully oversold to maximize daily use of spaces while minimizing the possibility that a space may not be available to a permit holder. Spaces are available and utilized on a first-come priority basis.
3. The use of all municipal off-street parking lots operated by the Village of Barrington shall be subject to such regulations adopted by the President and Board of Trustees of the Village of Barrington as they deem necessary and as such regulations may be modified, amended or repealed from time to time.
4. To guarantee a permit for next quarter, you must submit a new permit application and pay the appropriate fee between the 1st and 20th of the month proceeding the new quarter. Failure to renew your permit during this period may result in a non-availability of a renewal permit.
5. Overnight parking is not allowed in any of the Village Parking Lots with this permit.
