

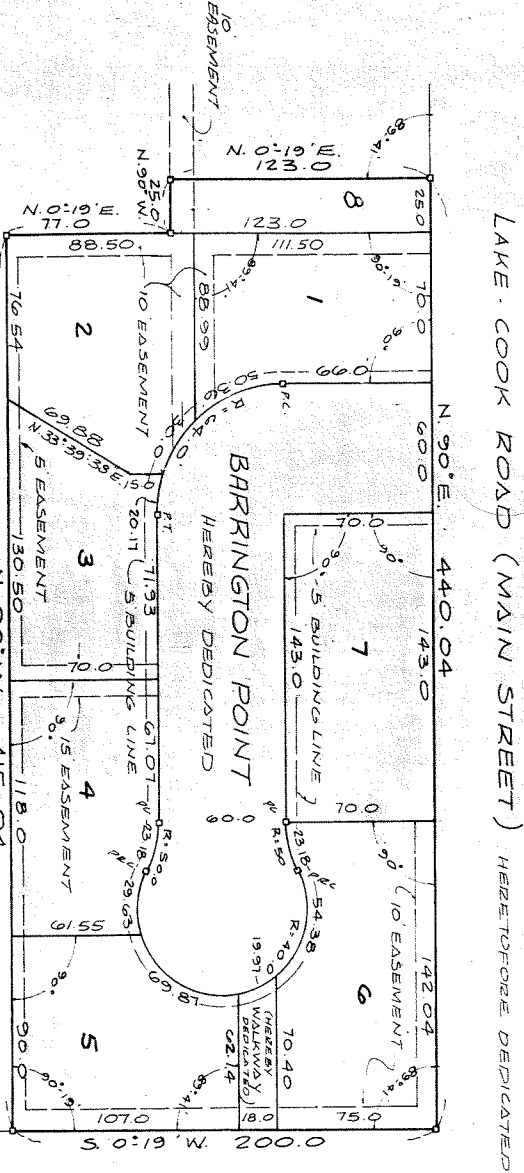
# BARRINGTON POINT SUBDIVISION
