

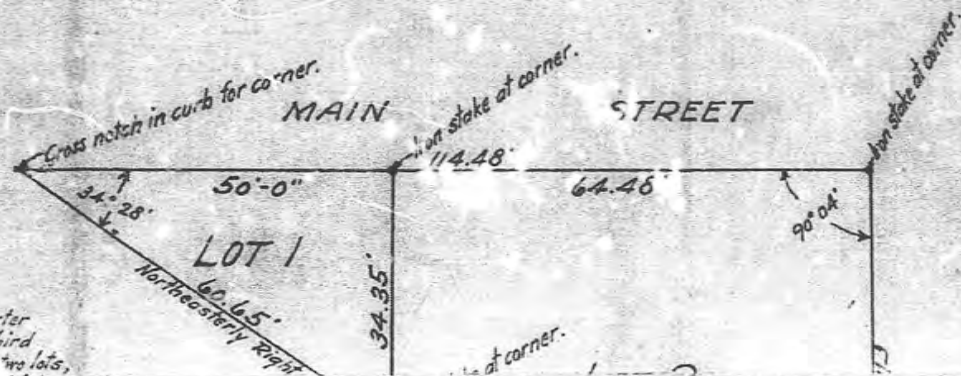
# BRASEL'S SUBDIVISION

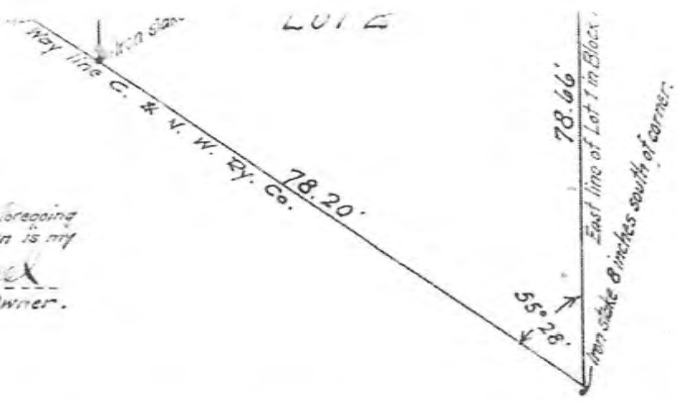
