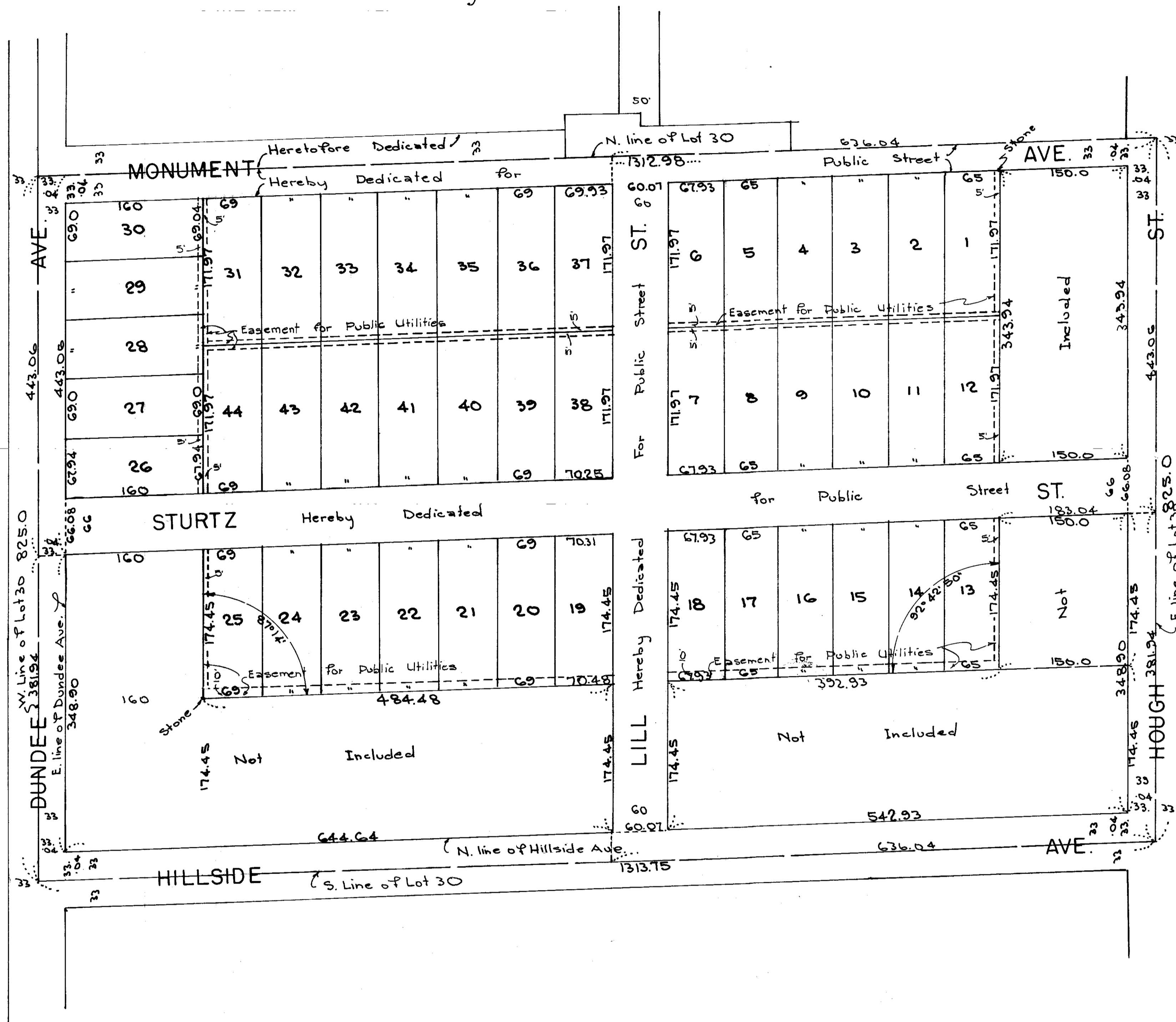
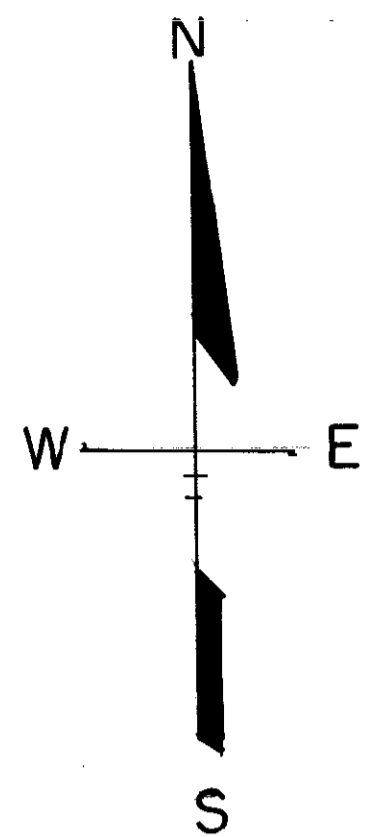


MARGARET E. WEYERS' EVERGREEN PARK SUBDIVISION
