

JOSEPH, an Illinois Registered Land Surveyor, do hereby certify that I have surveyed, subdivided into lots and platted for the owners thereof, that part of Lot 17 lying East of a line which is parallel with and 332.2 feet West of the East line of said Lot 17 and South of a line which is parallel with and 437.25 feet North of the South line of Lots 17 and 23 in County Clerk's Division of unsubdivided lands in the Southwest quarter of Section 36, Township 43 North, Range 9, East of the 3rd P.M., according to the plat thereof, recorded April 28, 1958 as Document 70831 in Book "D" of Plats, pages 62 and 63 (excepting from said tract of land the South 60 feet of the East 168.95 feet of said Lot 17 and also excepting from said tract of land the North 240 feet of the South 437.25 feet (measured on the East line) of that part of Lot 17 lying East of the East line of Ela Street and the North 264 feet of the South 437.25 feet (measured on the East line) of that part of Lot 17 lying West of the West line of Ela Street) in the Village of Barrington, Lake County, Illinois, as drawn on the annexed plat, which is a true and correct representation of said subdivision and survey.
