I, Harry I. Orwig, a surveyor, do hereby certify that I have surveyed that part of the Northeast quarter of Section 1, in Township 4<sup>th</sup> North, Range 9 East of the 3<sup>rd</sup> Principal Meridian, in Cook County, Illinois, that is described as follows: Beginning at a point in the north line of said Northeast quarter which is 66.0 feet east of the northwest corner thereof, and running thence south parallel to the west line of said Northeast quarter, 180.0 feet; thence west, parallel to the north line thereof, 66.0 feet to the west line thereof; thence south, along said west line, 413.0 feet, to the northeasterly line of the right of way of the Chicago and Northwestern Railway Company; thence southeasterly, along said northeasterly line of right of way, 519.0 feet; thence north in a straight line, 888.0 feet, to a point in the north line of said Northeast quarter which is 422.40 feet east of the northwest corner thereof; thence west, along said north line, 356.40 feet, to the point of beginning; that I have subdivided the same into thirteen lots and two streets, and that the plat hereon drawn is a correct representation of such survey and subdivision; and that the dimensions on said plat shown are in feet and decimal parts of a foot.

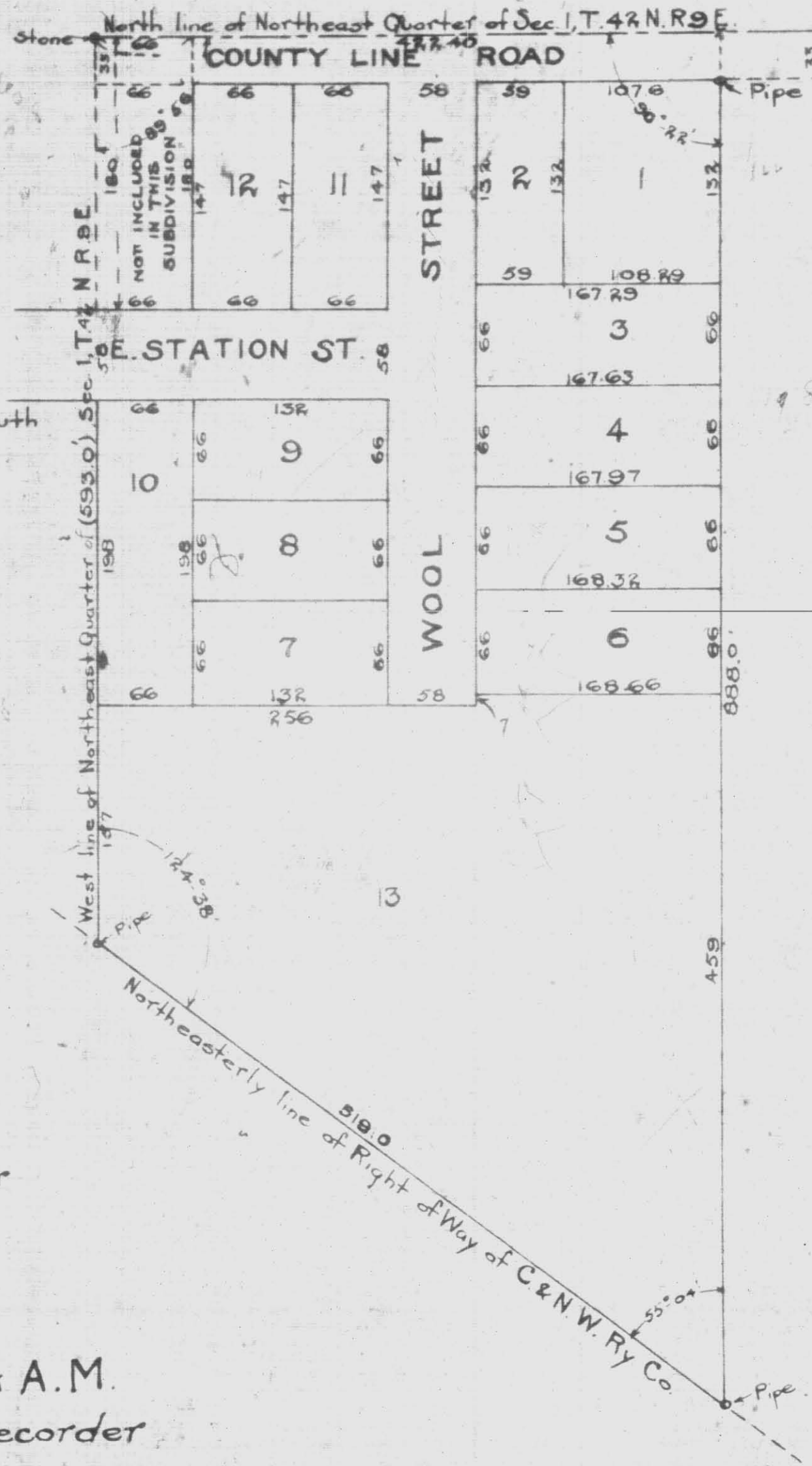
