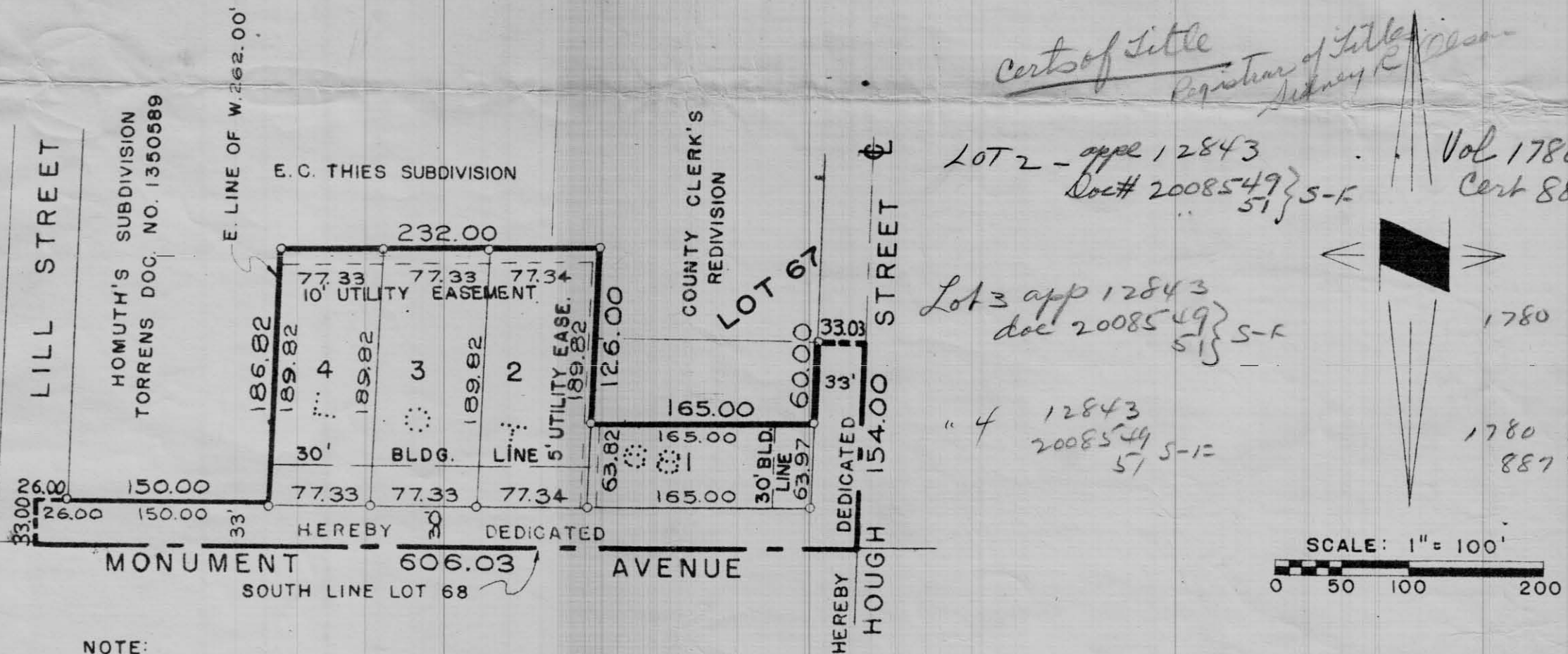


MONUMENT AVENUE SUBDIVISION
