ORWIG, an Illinois Registered Land Surveyor, do hereby certify that I have surveyed that part of the Northeast Quarter of Section 1, Township 42 North, Range 9 East of the Third Principal Meridian in Cook County, Illinois, that is described as follows: beginning at a point in the north line of said northeast quarter, 422.40 feet east of the northwest corner thereof; thence east along the north line of said northeast quarter, 132.82 feet; thence south in a straight line, 1015.6 feet to a point in the northeasterly line of the right-of-way of the Chicago and Northwestern Railway Company; thence northeasterly along the northeasterly line of said right-of-way, 224.4 feet; thence north in a straight line, 666.0 feet to the point of beginning also known as Lot 3 in the County Clerk's Division of the Northeast quarter of said Section 1; that I have subdivided the same into 4 lots, that the plat hereon drawn is a correct representation of such survey and subdivision, that the dimensions hereon shown are in feet and decimal parts thereof and are corrected to sixty-two degrees, Fahrenheit.
